Far-right activist Tommy Robinson and his supporters were given the run around when they arrived at a London police station to pick up a false driving conviction he needed to appear in court. Robinson and three supporters arrived at Holborn police station in the capital on Friday night to collect a witness statement that would be needed at his trial on 23 April. Robinson was originally given a 12-month driving ban but lost a court appeal and was offered a new trial. He had to appeal to the high court for another hearing, while supporters attempted to dig through their archives to find evidence. He will also have to re-take a driving test. Robinson was arrested in May 2018 and charged with perverting the course of justice following two separate hearings on unrelated cases. He was then sentenced at Leeds crown court. He spent two weeks in prison after being found in contempt of court but the sentence was suspended. He said he had not knowingly committed a crime and was seeking the new trial because he feared that he would be jailed for contempt of court again. Robinson said he believed the case was being decided on police station in Wembley and was arrested at the same time as a car chase involving his supporters. In a video Robinson posted to Twitter, he said he had also been charged with GBH. The 30-year-old said: "If it happens again then the CPS [the Crown Prosecution Service] will do it again, and they will say: 'He assaulted two police officers.'
