If, however, the party moving for summary judgment will not bear the ultimate burden of proof at trial, then the movant need not negate the nonmovant's claim and instead may satisfy its summary judgment burden by pointing out that there is an absence of evidence to support the nonmovant's case. See *Celotex*, 477 U.S. at 325, 106 S.Ct. 2548. If the movant satisfies its initial burden, the burden then shifts to the nonmovant to set forth specific facts *792 showing that there is a genuine issue for trial. See *Anderson*, 477 U.S. at 250, 106 S.Ct. 2505; see also Fed.R.Civ.P. 56(e). A nonmovant must do more than show that there is some metaphysical doubt as to the material facts. See *Matsushita Elec. Indus. Co., Ltd. v. Zenith Radio Corp.*, 475 U.S. 574, 586, 106 S.Ct. 1348, 89 L.Ed.2d 538 (1986). "[T]he mere existence of a scintilla of evidence in support of the plaintiff's position will be insufficient; there must be

evidence on which the jury could reasonably find for the plaintiff." Anderson, 477 U.S. at 252, 106 S.Ct. 2505. In considering a motion for summary judgment, a court is not to make credibility determinations or weigh the evidence; instead, it is merely to "determine whether there is a genuine issue for trial." Reeves v. Sanderson Plumbing Prods., Inc., 530 U.S. 133, 150, 120 S.Ct. 2097, 147 L.Ed.2d 105 (2000) (quoting Anderson, 477 U.S. at 255, 106 S.Ct. 2505). In doing so, the court must believe the nonmovant's evidence and draw "all justifiable inferences" in the nonmovant's favor. Id. at 255, 255, 120 S.Ct. 2097. IV.
